

EDITORIAL

A YEAR OF EDUCATION

One of the more significant changes in the Jewish community in the past year has been the increased prominence given to education in all its aspects. The United Synagogue Youth and Community Committee, which has developed valuable and indeed pleasurable study and recreational programmes for young people, has joined with the former London Board of Jewish Religious Education to form the United Synagogue Board of Education, A Year of Jewish Education has been marked by special events and further work is planned.

What change, apart from more confusion and interest led wrangling, is this intended to secure? You would be entirely justified in concluding that unless there is an impact on the members of our community individually and collectively it would not be very much. However, it is clear that there must be a wider realisation among all of us of precisely what is required to provide, and moreover operate sensibly and efficiently, Jewish education in its widest sense.

It is very significant also that increased effort is to be given to adult education in which our own communty has had a long

involvement. We must all see that as a new year opens that our individual stake in the Jewish world must be constantly revived. It is little use to expect that without the help we can give, others will take on and expand the provision of Jewish education. We can resolve instead, both individually and as a community that we wish not merely to be associated with others' efforts but also to join positively in supporting them. We will have an appropriate opportunity to do so by marking the New Year with a genuine decision to ensure our community continues to pledge all it can in financial and other terms so that what we value as Jews is able to be passed to our children and grandchildren.

At the same time we may reflect how much we need as individuals to renew our own attachment to our faith, to our fellow Jews here and in Israel and above all how we can achieve such a task. The coming year is a time for such renewal for all of us.

Chasanim

We are delighted to announce that our Chasanim for this year will be Mr. Maurice DeVries and Cllr. Joseph Mirwitch.

For Mr. DeVries it is the Bar Mitzvah year of his entering the box as warden of the Synagogue, an office he has adorned with great efficiency and assiduity, coupled with a marked sense of propriety, decorum and dignity. Despite his very heavy commitments as Borough Solicitor to the London Borough of Kingston, he still finds time to devote himself whoelheartedly to the needs of our Congregation.

Mr. Joseph Mirwitch has likewise given great service to the

London Borough of Hammersmith. In recognition of his dedication to the needs of the Borough, which he has served as a Councillor for a number of years, he was this year elected to the office of Deputy Mayor. Mr. Mirwitch is a solicitor working for the Post Office.

We look forward to our members and families joining in the Reception to the Chasanim who will be accompanied by their mothers, Mrs. Rose DeVries and Mrs. Gertrude Mirwitch. The

date will be the 17th October.

MINI-SERMON

There are moments in our life-time when we are motivated by some strange inexplicable force. We are inspired by a thought which crosses our mind — influenced by the words of a prayer or a sermon, or by the solemnity of our surroundings or by a

special occasion.

The High Holydays set all those forces in motion, geared as they are to stimulate our reason and kindle an emotional flame. One month before Rosh Hashanah the Shofar sounds its awakening call to us, to spend time probing our actions of the past year. We are asked to take an inventory of our behaviour, to search and probe our relationships, to discover and identify where we went wrong, to recognise the harm we have done and truly regret it, and finally to resolve that our misdeeds will not be repeated.

When the Days of Awe arrive, we can now place ourselves under G-d's scrutiny, and petition him to enable us to make

a good start to the New Year.

But one obstacle remains, even if we accept that we can

be confident of G-d's forgiveness.

Can we go to G-d to ask Him to forgive us for something we did to another person? If we wronged our friend Mr. A. would it be logical to ask Mr. B. to forgive us? Would we even approach Mr. B? Could Mr. B. have it within his power to forgive? Would his expression of forgiveness have any meaning if Mr. A. did not forgive?

Our High Holydays require us to search out each person who was affected adversely by our conduct during the past year, and acknowledge what we did, express our regret, apologize and seek forgiveness. This is not easy, but nevertheless, it is a pre-

requisite for G-d's forgiveness.

The mere knowledge that we must seek forgiveness of our friends, face to face, is in itself a deterrent factor to committing anything untoward. It is only then, in these circumstances that we are able to meet G-d with new strength and confidence in our prayers, having the thought at the back of our minds, that if our fellow man has seen fair to forgive us, then surely the Creator — the source of all Mercy — will forgive us too. We are now fully prepared to offer our Rosh Hashanah prayers.

sincerest thanks.

Our Chasanim this year were Rev. S. Venitt, Chasan Torah, and Dr. J. Cowan, Chasan Bereshis. Rev. Venitt celebrated his fortieth year ministering to our congregation and we extend to him and his wife Rifka our sincere thanks for their devoted service to our community. Dr. Cowan, a well respected member of our congregation and Board of Management has always been ready with help and support. We extend to him our congratulations on his recent wedding and are pleased to welcome his new wife Thelma to our community. At our Annual Reception both Chasanim were our Guests of Honour and after the usual vote of thanks they were presented with inscribed certificates commemorating the event on behalf of our congregation.

The Mayoral Visit by the Mayor of Hammersmith & Fulham Councillor Mrs. Joan Caruana accompanied by several members of the Council and our Local M.P. was held as is usual on Shabbat Shira. A special Kiddush was held after the service to

The Friendship Club under a very active committee chaired by Mrs. Netta Guyer, continue to hold their meetings in our Synagogue Hall. We are delighted that the club is flourishing and send them our best wishes for the future.

The Breakthrough

After years of lobbying by individuals and groups, 1987 has seen the exciting breakthrough in the cause for womens' equal participation in the administration of Synagogues within

the United Synagogue.

Since March of this year, it has been mandatory on all Synagogues to elect women to a Synagogue Council of Management. This replaces the singular Board of Management. The new administrative body incorporates the Honorary Officers, Board of Management, representatives at the Board of Deputies and United Synagogue Council and up to six female members (pratio of 1 female to 2 Board members) with full discussion and voting rights.

Women must be members in their own right to qualify for nomination. This has caused some confusion as many wives assume that as their husbands are members, with benefits covering his wife and family, she is automatically a member and eligible to vote at the Synagogue AGM and stand for election should she wish. This assumption is incorrect. Women who wish to make sure of their eligibility can contact the Synagogue

secretary or Honorary Officers.

In Hammersmith, the part women have played, whether individuals or groups, in caring for the well being of the community has been greatly appreciated by the Honorary Officers and has over the years built a working relationship of mutual

benefit.

Regretfully, this has not been so in some Synagogues. To achieve the change now taking place the Association of United Synagogue Women has worked long and hard. Inevitably there are some who argue for taking the change further. Nevertheless, this is an important first step. If young girls feel that they do not have an equal place within the Jewish community, as they have in the wider one, they will turn their interest elsewhere.

This first year is seen as a transition period, and each Synagogue congregation will build from it to suit their needs.

The Chief Rabbi's Rosh Hashanah Message

It is once again my pleasure and privilege to extend warmest greetings for the New Year to all the readers of this magazine,

While tensions in the world at large are ominously escalating — with trouble-spots threatening peace and stability far beyond their borders in places as distant as the Persian Gulf, South Africa and Central America — there have also been some notable advances on the credit side, among them the prospect of an arms-control agreement between East and West and the as-yet-intangible signs of some mild deliberalisation inside the Soviet Union. All these events have some direct bearing on Jewish fortunes, for, as a rule, Jews are the first beneficiaries of stability, and the prime sufferers of instability.

More real and visible have been some welcome manifestations of progress and solidity within the Jewish experience. In Israel, threats of terror and aggression have somewhat abated, and the National Unity Government has preserved the nation's cohesion against all odds and prognostications. Even the religious-secular conflict, gravely menacing as it still is, seems

to have lost some of its virulence of the previous year.

The plight of Soviet Jewry has eased only marginally, with the release of some more celebrated prisoners and refuseniks, and vague promises held out for lifting some repressive measures inside the country. But the indications are that major policy decisions on the Soviet attitude to both Israel and the Jews are still pending, and the situation continues to demand high statesmanship as well as perseverance on the Jewish side too, if the hope of rehabilitating millions of Jews is not to be abandoned.

The historic advance in Jewish-Catholic relations dramatised by the Pope's visit to the Rome Synagogue has unfortunately been compromised by several set-backs: the Carmelite Convent at Auschwitz, the beatification of Edith Stein and the reception of Kurt Waldheim at the Vatican. On the other hand, the happy relationship we enjoy with Christian leaders and citizens in this country is reflected in the singular honour bestowed on me by

the award of a Lambeth Degree.

Perhaps most marked have been some hopeful developments within our own community. The Year of Education has not only firmly established Jewish education at the top of our communal agenda, it also generated many valuable new enterprises which have caught the imagination of many congregations and their members. The restructuring of the United Synagogue, its new leadership, building ambitiously on the firm foundations already laid in recent years, augurs well for the consolidtion and revitalisation of Anglo-Jewry's traditional heartland. In fact, the sights should now be raised to encompass the expansion of the United Synagogue as an ever-stronger bulwark of Orthodoxy in the world - quantitatively by reaching out to kindred communities throughout the country in some associated confederation and qualitatively in devising some organisational bond with the newly-flourishing smaller units attracting many of our members' children by their very intensity and intimacy.

Other major urgent items also remain on our agenda for immediate action. There is the new secondary school planned by the JEDT, together with other important new educational enterprises; the co-ordination of our Jewish social services already begun under the aegis of the Central Council; the recruitment of high-calibre talent from younger elements for community leadership and the promotion of Jewish contributions to ethical integrity and moral excellence as well as in particular family stability in society at large — to mention just some specific objectives calling for broad vision and resolute action.

May 5748 bring the blessings of peace, security and prosperity in freedom and contentment, sustained by our own worthiness to merit these gifts, and accompanied by the progress of harmony among the nations, speeding the promised Redemption

for Israel and all humanity.

Mentally Handicapped Jews — The Challenge to You

To me, perhaps the most moving part of the Rosh Hashana service is the recitation of "Unetaneh Tokef" in the Mussaf service. In it we are told how G-d will judge our actions over the past year. One simply has to read the translation to conjure up an awesome and frightening image of a mighty G-d sitting in judgement, sealing our fate at the stroke of a pen. I am sure I am not alone in visualising this type of scenario. Yet, strangely enough, just when this imagery becomes almost too powerful, the verse changes its tone completely to convey a positively benign image:

". . . like a shepherd pasturing his flock, making sheep pass under his staff, so shall You cause to pass, count

and consider the soul of all the living."

How can the image of a shepherd tending his flock represent a G-d sitting in judgement? Our Rabbis explain that G-d judges all people individually, like sheep going single file through a narrow opening in a sheep pen. But he also looks on them as a shepherd would survey his entire flock. From this, say our Rabbis, we see that Man is not only judged at Rosh Hashana for his own personal achievements, but also for his efforts as part of G-d's entire 'flock'. In other words, on Rosh Hashana one must ask oneself "What have I done to serve the needs of my fellow Jew?"

Ravenswood looks after some of the less able members of our 'flock' — the mentally handicapped. We've shown that, given the right kind of facilities, the people we used to dismiss as

'ineducable' can achieve a lot. 30 years ago it would have been considered enough to give them a bed to sleep in. Today that's not enough. The sort of education and training we want to offer now is for life - an independent, near-normal life, within

the Jewish community.

When a mentally handicapped child is born the first question its parents ask is always the same. Why? Why us? But when some of the pain and anguish have begun to diminish, the other questions are just as difficult. How will our child survive with all the pressures of modern society? How can we make sure they get the best there is to offer in care and education? And, when we're no longer there to help, how can we give them the opportunity for a real home, a proper job and a fulfilled adult life? Inevitably, outside help must be sought. But then the questions change again. Who can help? Who has the expertise to know what's best? Who can provide the right facilities?

This year apart from the 1,000 mentally handicapped people we already look after, we will get calls for help from another 400 families. This year, we're going to continue making contact with all the Jewish people locked away in long-stay mental handicap hospitals. This year, we want to build more homes in the

community.

So perhaps this year when you stand in Shul and hear the Chazan recite 'Unetaneh Tokef' you will think about all the work entailed in tending some of the people in our flock. Perhaps you would like to become a volunteer, helping out at one of our residential facilities. Or perhaps you would like to help us by making a donation. One thing is for sure; if you can help us, you will certainly have done much to meet the needs of your fellow Jews, at a time when unity with Klal Yisroel - G-d's entire flock - is so significant.

Austria Before and After Waldheim

Dear Congregants, Dear Friends,

The recent reception of President Waldheim by Pope John at the Vatican resulted in the further escalation of antisemitism in Austria, as the Gemeinde, the official organ of the Kultusgemeinde in Vienna reported in its issue of 7th August.

Please allow me to take you back into the history of Austria and her hundred years of antisemitism. During the Habsburg Monarchy, the Jews were tolerated in the liberal atmosphere of a multi-national, multi-racial Empire. During the First World War, however, 1914-1918, the Jewish population in Vienna rose to 200,000, owing to the influx from Galicia-Bukowina (Russian, Roman and Polish areas).

As a result of the lost war, the breakdown of the Habsburg Monarchy into the various Succession States and the Treaty of St. Germaine left Vienna with the small Republic of Austria and a population of six million people. The capital had two million, with an ever-increasing Jewish population which had fled from the new republics. The term "Ostjude" came into the

the language of "the Wiener".

Austria, now a democratic state was governed by the Socialists and the Christian Volkspartei. Leading the Socialist Party were atheist Jews, Dr. Bauer, Julius Deutsch, Hugo Breitner and others, M.P.s in Parliament and Governors of the City of Vienna - "das rote Wien" (Red Vienna). Leaders of the Christian Volkspartei were the Catholic antisemites under the

leadership of Prelate Dr. Seipel.

The Jews profited from the Viennese Socialist rule. They obtained citizenship, stores, shops and exports. Banks flourished until the Wall Street crash resulted in bankruptcies. Unemployment changed the picture. Swastikas appeared on the scene. A book, Die Stadt Ohne Juden (State without Jews), written by somebody calling himself a friend of the Jews, Hugo Bettauer, gave a portent of what was to come. Then came Hitler, Austria, with almost a third of the people on the dole, greeted the Anschluss with flags and the Austrian Nazis began robbing and killing Jews in ten days, showing more brutality than the Germans in five years.

This is Austria before Waldheim!!

In 1945, after the Holocaust, a few hundred Jews trickled back. After 1948 some came from Prague, followed after 1956 by Hungarian Jews who settled in Vienna, and in more recent times, the Russians,

So today there are 7000-8000 Jews registered with the

Kultusgemeinde.

They are well organised - the famous Seitenstadter Tempel

gives beautiful Shabbat Services.

Antisemitism was below the surface - asleep until Waldhelm as Presidential Candidate and the protests from the USA awoke the anti-Jewish elements - with the help of the Volkspartei.

May I end with a few questions?

1. The World Jewish Congress knew (and must have known) of Dr. Waldheim's past. Why did they not raise it during his eight years as UN General Secretary?

Why did Lord Weidenfeld publish his book?

3. Why did his editor not ask Waldheim about the missing two

vears?

Now, my friends, if you are not tired of reading my story, I am going to the Catholic side, with a few questions: Why did Pope Pius the XII, previously Cardinal Pacelly in Germany, not help the Jews? Why did Cardinal Innitzer of Vienna greet Hitler on March 11th 1938 as the greatest German?

The Catholic Church never liked Jews!!

ROMAN MITZVAHS

It was Second Day Shayuot. The temperature was 75°F. We set out for the Synagogue in Rome just by the Tiber which flows through Rome but, to my mind, not as majestic as the Thames through London. We arrived at the Great Synagogue after 10-12 minutes walk and came upon this huge, imposing building which, at first glance, looked as if we had reached the largest Shul in Europe. It certainly was the highest one I had seen and when we approached the entrance we were stopped by several male "security" congregants who asked us if we had any cameras. On satisfying them that we were "kosher" they courteously directed us where to enter - ladies round the corner of the Shul and then upstairs, the men straight ahead. But before we walked on, we could not help but notice the Police Van parked outside and police with automatic guns standing around. After all, wasn't this the Shul that only a few short years ago received the full blast of the terrorists and a few of the congregants were killed or maimed.

On entering the Shul we had to brush aside a curtain that hung across the main doors and, on entering, we picked up a tallis from a table which literally held dozens. There was also a table on which there were also dozens of copples, if one required it. A Chazan was already chanting the prayers (it was about 9.30) through a microphone, I hasten to add!! They davened in the Sephardi accent coupled with a strong Italian influence so that it was not easy to follow the service. However, their Siddur was very familiar to us and it was all in Hebrew with no Italian translation (not that this mattered to us) but we managed to follow a lot of the Service. Glancing around, we noticed the Chief Rabbi of Rome was sitting in the place of honour, the Rabbi of the Shul sat next to him, another Chazan sat nearby

whilst the second Chazan was davenning.

Above all, there was a choir, all-male, behind the Ark whom we could not see and the Bimah was just in front of the Ark—just like Hammersmith's, only on a vastly bigger scale — all in marble as was the rest of the Shul. It was about 50% higher than our Shul and twice as wide. All seats faced the Ark in four blocks with lovely stained-glass windows all around. A magnificent Ark was approached by first walking up to the Bimah, then ascending about 6/7 steps to the curtaining of the Ark. On pulling the curtains aside there were two doors to open and then a final curtain and several very large Seforim.

Being Shavuot the Bimah and surrounds were covered with the most beautiful flowers extending to the floor of the Shul in

lovely containers, bowls and vases.

When the congregants were called to the Reading of the Law each went up with their teen-age daughter holding hands and later on we observed there was a Bat Chayil ceremony which took place at the end of the Service. The girls (about six of them) all stood in front of the Ark with the Chief Rabbi and, although we could not hear them, I believe they must have recited one or two prayers and/or Psalms — still facing the Ark

— and at their conclusion the Chief Rabbi pronounced the Priestly Blessing. Even though we seemed to be the only non-Italians in the Shul, it seemed strange that no-one came up to us, which I thought most unusual as it is the usual thing at Hammersmith to greet the "stranger" with a welcome.

I haven't forgotten the ladies. They sat upstairs in the 3-sided gallery although on that day all the ladies sat in the centre gallery. It was through a lady in our party who sat next to a congregant of the Shul that we learned there was a Bat

Chavil ceremony taking place that morning.

What impressed me was the utter magnificence of the Shul itself, and if anyone has the opportunity of visiting Rome, a visit to this Shul when a Service is taking place is a "must".

Yes, a rather unusual and impressive Yom Tov.

International Conference

Coinciding with the 20th anniversary this year of Israel's magnificent victory in the Six Day War, increased attempts are being made to convene an International Conference to consider the future of the West Bank and Gaza seized in that War as a

result of Arab agression.

This suggested Conference looks a long way ahead. Its aim is to enable Jordan to enter into direct negotiations with Israel as instructed by the Conference, which would include the five permanent members of the United Nations Security Council. While Prime Minister Shamir and his Likud Cabinet Ministers are opposed to the Conference contending that it will only pressurise Israel to make concessions instead of engaging in direct negotiations, Foreign Minister Peres and his Labour colleagues are in favour of it to provide King Hussein an international framework within which to negotiate, in order to overcome Arab objections to direct negotiations.

However, the positions adopted by Shamir and Peres are in reality not too far apart. Both agree that on no account will there be any PLO participation, as its oft-proclaimed aim is to destroy Israel backed with acts of terrorism. Both agree that there will be no Soviet participation unless the Soviets resume diplomatic relations with Israel and improve the situation of Soviet Jewry. Before fulfilling these conditions the Soviet Union might seek to influence the course and outcome of the negotiations. This is wholly unacceptable to both Peres and Shamir. It is true that the United States can veto any decisions of the Conference and Israel can refuse to implement them, but Israel's image will suffer in consequence.

When Peres was in London in June, he said at a public meeting in reply to my question, that both the Soviet Union and China, as permanent members of the Security Council, would have to have diplomatic relations with Israel.

In a sense, both Peres and Shamir are right and there is no need to break up the National Unity Government before general elections due in 1988. Peres is right in trying to find a way out for Hussein in his dilemma, and Shamir is right in seeking to ensure that such a Conference will not just pressurise Israel. The momentum toward peace could be maintained through careful preparation for the Conference, by clearly defining its commitments, its agenda and its participants.

THE NEW SPEAKEASY

Two furtive figures checked that the coast was clear before entering the bakery. They nodded to the man behind the counter and went to the back of the shop. The man knocked twice, paused and then three times more. A small window opened in the door. "I'm a friend of Sam" the woman said. The door was unbolted and the couple walked down the stairs to where the lights were bright, the music was playing and their drinks were waiting.

Hampstead High Street and the United Synagogue may not seem to have much in common with the scene above. Yet like the Speakeasy itself, appearances can be deceptive. Speakeasy is the name given to a new project launched a few months ago by the United Synagogue Youth and Community Services (USYC for short). It was aimed at helping with a problem that was

gaining a considerable amount of attention.

The scene was becoming quite familiar to the inhabitants of Edgware. Saturday nights and the forecourt of Edgware station would be full with young people. Teenagers with apparently nothing to do and nowhere to go. Youngsters who seemed to have more cash than they know what to do with. Boys and girls, so it was reported in the always reliable Jewish Chronicle, who were becoming involved with the drugs scene.

The police appeared, Lubavitch arrived, the Board of Deputies inconspicuously were everywhere and suddenly Edgware was not quite the "in" place anymore. Now it was Hampstead and on Thursdays too. People were travelling in from as far away

as Ilford just to be there and be seen.

So the High Street would fill, the car drivers would curse, the local residents complained, the police distributed leaflets warning that there might be arrests for obstruction and suddenly winter arrived and it was cold so everyone could forget about the situation.

What was the problem. Nobody seemed terribly sure. USYC were sure of one thing. The problem was not the children. They were perfectly happy meeting each other and spending time talking together. The people who seemed to be upset were the adult community. The cry went out that these kids should have somewhere else to go. The residents of Hampstead wondered why they were camping on their doorsteps and all wished that the boys and girls would go somewhere else and play. The youngsters could have replied very simply — where?

Speakeasy set out to try and create a place where young people could just drop in, find a coffee and some company. It was not just a question of opening up a Shul hall, since most of these youngsters would not go anywhere near a Shul. As it happens the place chosen used to be a Shul (my parents were married there) but has since moved. The old Beehive Lane Synagogue was unused. Ilford is the largest Jewish community in Europe. It seemed a good place to start.

The Speakeasy coffee shop is currently open on Sundays from 7.30 p.m. until late and on Wednesdays from 4 p.m. until 6.30 p.m. The search is on to find another centre in the North West area. The shop is opened by young volunteers and counsellors are always available if people have anything they wish to

talk about.

The coffee shop has attracted interest but inevitably some of the Hampstead regulars are not going to be interested. The second approach Speakeasy uses is to go out to them. People have been wandering around the same areas as the crowds, getting to know the young people, becoming familiar sights there and being there if people want to talk. This approach is by far the hardest and slowest but it has been used by individuals for a couple of years and Speakeasy have integrated their expertise into the project.

The final strategy used is in opening a telephone counselling service. Volunteers are at the end of a phone (202 1441/2) between 4 p.m. and 10 p.m. on Sundays and from 5 p.m. and 8 p.m. on Mondays. If there is nobody there, we have a 24 hour answering machine that will take messages which we can return at the

next session.

As expected, this started slowly but more and more calls are being answered as people begin to hear about the service. They range from the Mum phoning for her daughter about to come to London who doesn't know anybody, to far more serious problems. The phone line, as all the Speakeasy services, is aimed at young people and absolute confidentiality is guaranteed.

The project has been fortunate in receiving a lot of advice from experts who have considerable experience in these areas. The volunteers are all put through a short training course on counselling in general and a separate course for the particular area in which they will be involved. Trained counsellors are always available to people at the coffee shop or phoning in. Speakeasy is up and walking. More volunteers would be welcome (phone USYC on 202 7529) and we will start running and then sprinting as more people start to hear of us. We will not stop young people wanting to spend time at Edgware or Hampstead but we are providing somewhere for them to go and someone for them to talk to.

Sam's two friends stumbled upstairs back into the bakery, lighter in the head and lighter in the wallet. It had been another wonderful evening despite the cloak and dagger start. They both looked forward to a time when they could walk freely into a club. A place where they would not have to worry about being raided by the police. Somewhere they could relax and know they were welcome.
