Special General Meeting
October 2014

The Trustees Annual Report on pages 1-3 lists the names of the trustees who were the members of council who acted during the year, together with the statutory legal and administrative information of FPS required by the Charity Commissioners. Page 4 is the Independent Examiners Report of our external accountants who conduct a limited review of the accounts without carrying out an audit before approving them.

Page 5 is the Income & Expenditure account for the year. The accounts for the Year Ended 31st December 2013 show a deficit of £6,339 which is the amount by which expenditure exceeded income over the year compared to a deficit of £2,080 in 2012, £24,218 in 2011 and £19,927 in 2010.

Last year it was decided to exclude legacy income from the final profit and loss calculation so that the figures reflected the true operating cost of running the synagogue. Legacies and some donations were utilised on specific and necessary projects. This year was our 60th Anniversary and it was agreed that our efforts would be directed towards making it a truly memorable year and not towards seeking donations. During the year in pursuit of this aim significant unbudgeted expenditures were incurred both for the refurbishment of the premises, in staging the Anniversary events and by commissioning the mosaic which now adorns the Entrance Porch.

These following unbudgeted items are the most significant contributing factors to the deficit for the year.

Refurbishment of premises	£15,082

It was intended to replace the Security Gates during the year but this has now been postponed to the current year and half the cost is being covered by a grant.

Rabbi and Staff salaries have remained relatively stable as Rabbi Rebecca, Synagogue manager (Pauline Gusack) and Community Services Manager, Angela Wharton have remained in post throughout the year. This has helped stability and efficiency in Religious activities and office and premises administration.

There was an average increase in subscriptions of 3% to counter the effects of the prolonged recession. As many members and families continue to struggle your council

continued to offer concessions to those most in need. In spite of this the subscription income was only marginally less than last year, due mainly to the one-off effect of the very successful effort by Angela Wharton the previous year in reducing outstanding subscriptions.

The Board of Trustees will continue to look at ways of meeting synagogue costs by balancing the level of Subscriptions and seeking funds from external sources to ensure the finances of FPS remain stable. The Board continue to encourage Donations and Legacies with the latter offering a saving of 10% on Inheritance tax bills to those estates leaving at least 10% to charity.

What is essential is that costs continue to be controlled and monitored carefully throughout this difficult period in the economy.

Page 5 of the accounts is the Balance Sheet which is a Statement of Financial Affairs of FPS listing the Assets and Liabilities at the end of the Calendar year. FPS remains in a sound financial position with Total Net Assets at £500k primarily represented by the cost of the building and liquid funds in the bank. In terms of cash you will see from the balance sheet that it has Cash at Bank at 31st December 2013 of £137,830 which after subtracting restricted cash balances of £117,900 shown at Note 9, leaves FPS with liquidity of £ 19,970.

On pages 7 to 9 you will find the notes to the accounts, which I hope are self-explanatory. However if there are any questions on these accounts, please do not hesitate to contact me.

I would like to thank everyone who has provided me with valuable support including Bob Kingston who was instrumental in producing these accounts and our longstanding book-keeper Hilary Roer. Thanks are also due to Laura, Joan and Josie for their guidance and help in deciding our priorities, especially during this 60th Anniversary year.

This was my first year as treasurer and I would like to thank the Executive, Rebecca and council for their interest in, and responses to, my attempts to present them with an ongoing overview of the finances. Also to their participation in the budget setting exercises that we carried out last year and this year in order to maintain the finances of FPS on a sound footing.

Name of person or body entitled to appoint trustees (Council Members): The membership in general meeting of Finchley Progressive Synagogue.

Structure, Governance and Management: The synagogue's governing document is its constitution. The trustees are its Council Members. They meet regularly throughout the year and there are sub-committees and groups which report to council. In addition the synagogue employs administrative staffs who are responsible for the management of the building, day to day finances and co-ordination of activities. All significant operational decisions are made by Council, with certain key decisions approved by the membership in open meeting.

Objects of the charity: To advance religion in accordance with the beliefs and tenets and doctrines of Liberal Judaism. The synagogue is a member of Liberal Judaism, for which benefit affiliation fees are payable.

2. Activities and Achievements.

Under the direction of its Rabbi, the synagogue and its members continue to provide religious, cultural and communal facilities and to support members and their families during the year.

Rabbi Rebeca Qassim Birk has led the community throughout the year ably supported by synagogue manager, Pauline Gusack and administrative officer, Angela Wharton.

3. Grant Making Policy

The synagogue pursues its charitable giving through a number of programmes, such as the High Holy Day Appeal and voluntary subscription levies.

4. Accounts

The accounts for 2013 are presented within this report. The trustees are advised, by their accountants, that no audit is required this year. The trustees confirm that the accounts and the notes thereto comply with current statutory requirements, the requirements of the synagogue's constitution and the requirements of the Statement of Recommended Practice for Charities (Revised 2005)

There was a net deficit of unrestricted funds for the year of £12,471 (2012: £2,080 deficit). Total income (excluding Legacies) increased by £12,608 (2012: decreased by £1,638)

Total Expenditure rose by £9,587 largely due to an increase in refurbishment costs and costs associated with the 60th Anniversary celebrations.

At 31 December 2013 the synagogue held unrestricted funds of £381,926 (2012: £397,321) and restricted funds of £124,237 (2012: £109,669). The trustees believe the financial position remains stable and will continue to monitor costs carefully throughout a continuing difficult period in the economy.

The Funeral fund holds an asset comprising a loan of £50,000 made to Liberal Judaism to facilitate the expansion of the Edgwarebury Lane Cemetery. An agreement has been reached on staged repayment of this loan starting in 2014.

5. Reserves Policy

It is the policy of the synagogue to maintain unrestricted funds at a level, which is sufficient to keep the synagogue solvent. In conjunction with the subscriptions and other income resources this provides sufficient funds to cover administrative and support costs.

6. Risk Assessment

The trustees confirm they have considered the major risks to which the synagogue is exposed, as identified by the trustees, that they have reviewed these and consider that appropriate systems have been established to mitigate those risks.

Basis of Independent Examiner's Statement

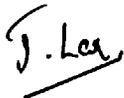

1 Principal accounting policies

Accounting convention

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities and with the Charities Act 2011. In preparing the financial statements the charity follows best practice as laid down in the Statement of Recommended Practice Accounting and Reporting by Charities (SORP 2011).

Resources expended

Expenditure is included on an accruals basis.

Tangible fixed assets

All assets, other than consumables and items under £5,000, are capitalised.

Depreciation is not charged on freehold land and buildings. Furniture and equipment is written down on a straight-line basis over their estimated useful life at the rate of 25% per annum, however no depreciation has been charged in the current year as Council considers it to be written down to net realisable value.

Fund accounting

Details and the nature and purpose of each restricted fund are set out in note 9.

Recognition of incoming resources and liabilities

Subscriptions are included in the Statement of Financial Activities (Sofa) upon receipt.

Grants and donations are included in the Sofa, when the charity has unconditional entitlement.

Tax reclaims are included in the Sofa at the same time as Gift Aid claims are submitted.

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.
